GAINING ENTRY TO OUR ANNUAL LIST OF THE TOP 100 Most Influential People in Accounting isn't easy, but it can be done. We've put together a list of some of the activities that most of our T100 engage in. All you have to do is commit yourself to the following for the next year or so.

Innovate and create. One sure-fire way to influence the accounting profession is to build something useful for them — a tool that revolutionizes how audit confirmations are collected, for instance, or a clearinghouse for safely sharing financial information, or just the software they use everyday. But you can also create ideas — like standards for sustainability, or new ways to market professional services.

Educate. Whether it's great big game-changing ideas or the intricate details of the least-important section of the Tax

Code, teaching the profession something it didn't know is a sure path to influence. (Just be sure to teach a lot of people.)

Regulate. Enforcing the rules automatically comes with one form of influence, and that's the kind we recognize most often. But in the right hands, it also creates the ability to call for the best in those being regulated.

Cross-pollinate. A small but vibrant subset of our T100 is composed of people who specialize in bringing together firms through M&A — but on a broader level, everyone on this list is constantly in contact with people throughout the profession and beyond, making introductions and connections and bonds that might not have happened without their influence.

Elevate. The profession has high ideals and a very bright

future. Those who help it meet those ideals, and those who are actively planning that bright future, are among the most influential of all. All you have to do is become a nationwide thought leader, or start envisioning and building the structure of the profession for the next five, 10 or 20 years.

Finally, to guarantee your spot on the list, you should also travel far, far too much. If there's one thing that unites almost all of the Top 100, it's that they spend an awful lot of time in airports. Even in these days of Skype and social media, building influence is still often best done face to face (or face to faces).



Just a few more ...

We need to find a way to cram more people into the Top 100, because new and interesting people keep rising up to change the profession. Until we can get 150 or so people into a 100-person list, however, we offer our annual list of Ones to Watch men and women whose influence is waxing, and whom we'll be keeping an eye on.

Top of this year's OTW is, unsurprisingly, whoever will serve as our next president: Hillary Clinton or Donald Trump. We won't tell you who to vote for - but we will strongly suggest that you do vote, and think hard and read widely about your choice beforehand

While we're discussing matters governmental, we might also mention that we'll be paying attention to interim Securities and Exchange Commission chief accountant Wesley Bricker, who is filling in for James Schnurr while he recovers from a serious bike accident (a recovery we hope will be speedy and complete).

On the regulatory front, it will be interesting to follow Charles Noski, the new chairman of the Board of Trustees of the Financial Accounting Foundation. As we note a few times in our main list, the U.S. standard-setters that the FAF supports are at the beginning of a new chapter in their history, so what Noski and his colleagues do will have serious long-term implications.

As is often the case in this space, we'd also like to note a number of advisors and consultants. Accounting is lucky in that it can call on the advice, insights and services of an ever-expanding roster of experts; here are some we're keeping an eye on:

Andrew Argue, of The Argue Co.: In a stunningly short time, Argue has built up a loyal following among a large number of firms for his advice on growth.

Martin Bissett, of the Upward Spiral Partnership: His twin focuses on making sales palatable and clearly defining a path to partnership answer two of the profession's biggest issues.

Carolyn Carlson and Richard Stanger, of StangerCarlson: These two bring a unique approach to M&A, succession and firm management that is rooted in part in their HR expertise.

Phil Whitman, of Whitman Busi ness Advisors: Whitman has built an experienced team to help him assist

firms - particularly at the larger end of the spectrum - with growth, succession, transition and other issues.

There are also practitioners who share their expertise with the rest of the profession (and the world), often in interesting ways. Among this group we recommend two to your attention this year: Seth David, of Nerd Enterprises, who uses his YouTube channel, online "School of Bookkeeping," online hangouts, speaking engagements and other outlets to educate, inform and inspire; and Hector Gar cia, a Miami-based CPA and QuickBooks expert who also uses YouTube, as well as his blog, webinars and live presentations to help the profession make the most of QB, one of its most common tools.

They aren't the only ones sharing their expertise. While we've long noted the influence of tax blogger Paul Caron, many others are now using the blogosphere to share tax information, analysis, insights and, occasionally, humor. This year we're going to cite two, both of whom appear on Forbes.com: WithumSmith+Brown partner Anthony Nitti (who also writes on taxes for many other outlets, and frequently teaches well-received CPE courses), and Kelly Phillips Erb, a tax lawyer whose "Tax Girl" blog draws lots of eyeballs. And while we're on the subject of taxes, you might want to keep an eye on Howard Gleckman, a fellow at the Tax Policy Center think tank, whose thoughts on tax policy are often sought after by the mainstream media.

Last but not least (and in no particular order), we want to include a number of people in the tech sphere:

Mike Sabbatis, a veteran who recently returned to the field by joining workflow pioneer XCM Solutions. Marc Schiepe, who took the reins at

Sage earlier this year.



On the assumption that the T100 People were accomplishing more things on a regular basis than we were, we asked them to tell us what their most important "productivity tool" is. We expected a long list of apps (and we got plenty, which you can read about in full on AccountingToday com), but many of the T100 used a loose definition of the phrase.

As an example: August Aquila said, "I am the most important productivity tool that I can use," in the sense of persona organization. He deletes anything he doesn't need immediately to reduce clutter, knows his peak cycles of productivity so he can schedule his most importan tasks for those times, and lets everyone around him know of his commitments so they can help hold him accountable

For those who don't want to rely or themselves, someone else can come in handy. Jason Blumer allows a persona assistant to fully manage his calendar, and saves from 10 to 15 hours a week. Ken Bishop, Gale Crosley and Allan Koltin all mentioned their personal or virtual assistants; interestingly, Crosley's works remotely, and the two have never met.

On the other hand, Denny Schleper said, "The elimination or reduction of personal assistants has increased pro ductivity tremendously," because it forces people to rely on new tools and eliminate duplication of efforts.

Jim Bourke likes delegation, as does Sandy Johnson, who said, "I learned a very long time ago that I can't do it all, nor do I want to."

Ed Karl uses a similar tool: "Recruiting coaching and advancing a pool of competent colleagues. I put trust in them and let them do their jobs." The value of a team was similarly clear to Joanne Barry and Jim Boomer.

Cindy Fornelli relies on a strong team at the CAQ, too, but also cites scheduling some time — even just a few minutes every day just for thinking.

Ed Mendlowitz, Marc Rosenberg and Sarah Johnson Dobek, meanwhile, all praised the value of a good to-do list (Johnson Dobek's is hand-written, which demonstrates serious commitment).

And naturally, Ron Baker offered the final word on the pursuit of productivity citing Peter Drucker and Stephen Cov ey: "Don't confuse being efficient - or being busy — with being effective (doing the right thing)."





No, it's not an accident

Those of you with long memories (or excellent visual recall) may be wondering if this chart is exactly the same as last year's - and we can certainly understand the confusion, since it looks an awful lot like it, with a single huge spike on the far left, and a big dropoff after that.

But we can assure you that it's not exactly the same; in fact, there are a number of minor differences — it's just that American Institute of CPAs president and CEO Barry Melancon remains far and away the most influential person in accounting in the opinion of the candidates for our Top 100 list. Almost half of the 125 candidates who named their picks for the three most influential included him, citing his unparalleled knowledge of the profession, his vision for the future and his success in pursuing it, and his passion for accounting. To put that in perspective, the 125 respondents named over 130 different people from a wide variety of backgrounds as influential, so it's significant that so many agreed on Melancon. (Note that there are closer to 150 candidates for the T100 list every year; not every one submits a response.)

Maryland Association of CPAs chief Tom Hood kept his position as the second-most influential person in accounting, and he too was lauded for his long-term vision for the profession. Value pricing philosopher Ron Baker, Financial Accounting Standards Board chair Russell Golden and Securities and Exchange Commission chair Mary Jo White also kept their spots high on the list, as did peripatetic AICPA vice president Mark Koziel.

Perhaps the most interesting change was the rise in perceived influence of cloud accounting, with Intuit chairman and CEO Brad Smith more than doubling his number of votes from last year, while his rival, Xero founder Rod Drury almost tied him. The two represent the foremost competitors in a battle to be the leader in providing online accounting solutions to small businesses (and their most trusted advisors) — a competition that can only result in better software, and more people making the important move to the cloud.
